TOURNAMENT RULES

- 1.*USBC rules apply. Member must have an adult USBC card. Non-USBC members can qualify for entry by purchasing a USBC associate membership or by paying a participation fee of \$5.00. Walk in entries are allowed with no late fees.
- 2.*Handicap: 80% of the differences between the highest certified average and 200. (Team, 800; Doubles 400; Singles 200).
- 3.***Average:** Entrants will use their highest USBC-league average based on a minimum of 21 games for the 2023/2024 season. If the current 21-league game average as of April 1, 2025 is 10 or more pins above the 2023/2024 season's average, the current, higher average must be used. If no average was established last year, use the highest current USBC-sanctioned league average for 21 games or more, as of April 1, 2025. All others bowl scratch with a 200 average. USBC Rule 319e is waived for the purpose of this tournament. All averages must be certified by a league secretary or team captain.
- 4.**Singles/Doubles:** *If a bowler bowls singles, she must bowl doubles, and vice versa. No exceptions.
- 5.*Multiple Participation: For team, bowl up to 10 times provided that no more than 2 bowlers repeat on the same team. The first team series will count toward the bowler's All Event score(s). For doubles, bowl up to 10 times but cash only once with the same partner. For singles, bowl up to 10 times, but cash only once. The first singles and doubles series will count toward the bowler's All Event score(s).
- 6.***Substitutes:***All efforts must be made by a team captain to replace a bowler with a substitute; the Tournament has a very limited pool of local bowlers and will not be responsible for providing a replacement for an absent bowler. Any substitute provided by the Tournament will not be required to reimburse the original entrant with the entry fee paid, nor shall the substitute be expected to give the original entrant any prize money or trophy she may win.
- 7.***Entry Fees:** To be eligible for a cash prize in All Events (optional), an additional entry fee must accompany entry. No entry application will be accepted unless accompanied by an entry fee. USBC Rule 314: After an entry has been received and the dates assigned are not refused before preparation of the schedule, the entry fee cannot be refunded.
8. All prize funds received will be returned 100%. *Prize ratios for singles, doubles and team events shall be 1:10. All Event Handicap and All Event Scratch shall be 1:12.
9. All captains awarded prize money will be provided an itemized recap of winnings with a check and it will be the sole responsibility of the captain to disburse prize money to individual bowlers on her team.
- 10*Any protest affecting eligibility of general play rules must be confirmed in writing to the Tournament Manager before the tournament prize payments are made. The decision of the Tournament Management will be final unless a written appeal is filed with USBC Headquarters in the prescribed amount of time per USBC Rule 329.
- 11.*Entrants need not report previous tournament prize winnings. (Rule 319d is waived.)
- 12.*USBC Rule 309. All awards shall be granted and all financial statements and awards lists shall be submitted to USBC within thirty (30) days after the tournament ends.
